However a change in tax law (P.L.103-66) has determined that the portion of dues estimated to be directly allocated to lobbying activities (using IRS definitions ) is no longer deductible as a business expense. The portions of your annual dues estimated to be allocated to the lobbying portion of our overall legislative effort, which is nondeductible, is 10%.
